What is exit risk?

Exit risk is the potential for affordability or eligibility restrictions to expire or be terminated. This leads to the loss of homes from the nation’s affordable housing stock. 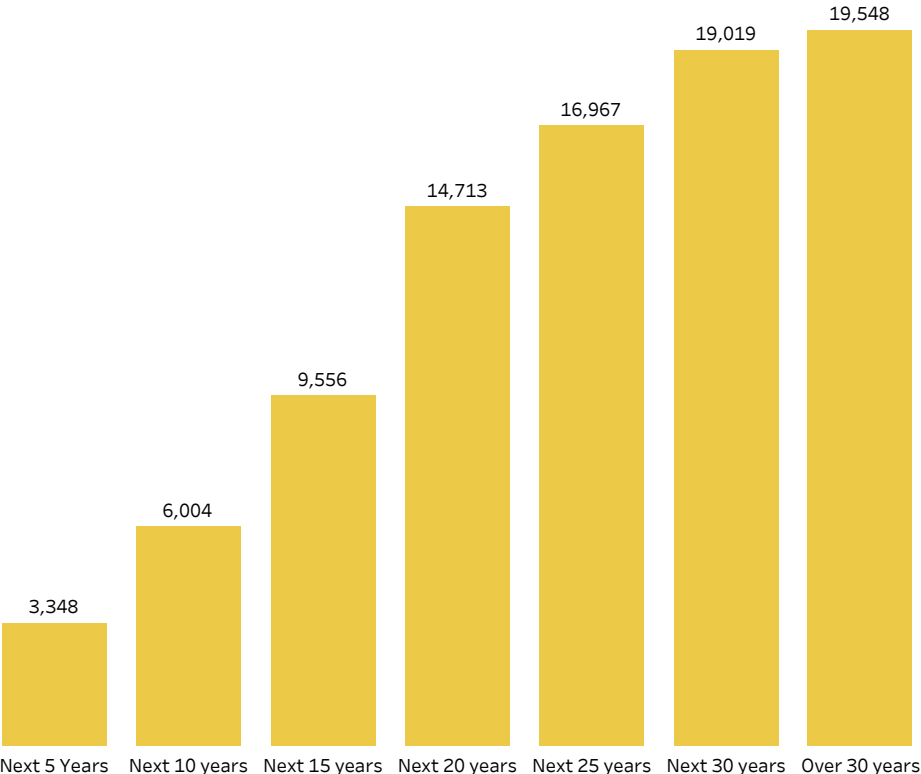

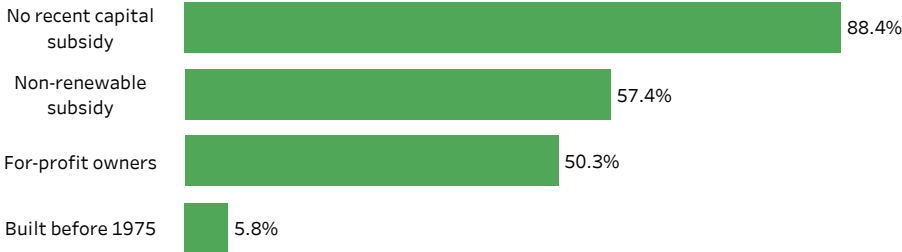

Federally Assisted Homes Facing Exit Risk Over Time



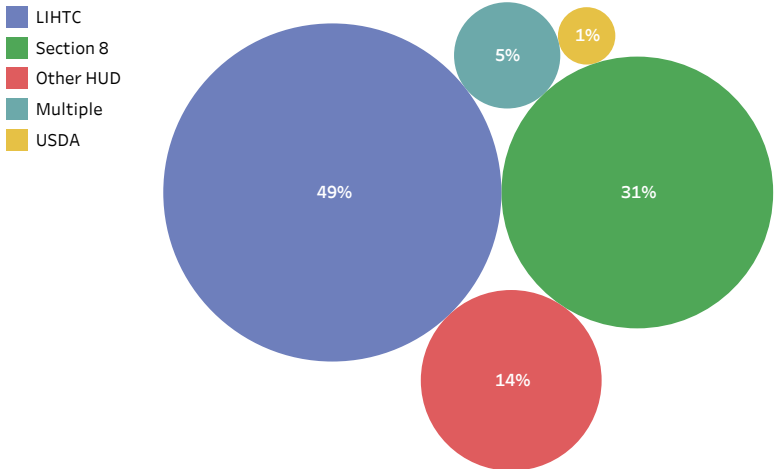
12.5% of federally assisted homes face an expiring affordability restriction in the next five years

Exit Risk Characteristics for Federally Assisted Homes Expiring in the Next Five Years



88.4% of federally assisted homes expiring in the next five years have not recieved a capital subsidy in 20 years

48.6% federally assisted homes with expiring affordability restrictions in the next five years are assisted by Low Income Housing Tax Credits
